## Coordinators Report:

- Pedro Lucero contacted staff Friday afternoon and decided not to join the FBID board with plans to step down from the Downtown Merchants Association.
- The county is talking about offering services related to mental health services and opening them to business owners and community leaders in economic development that have been affected by the pandemic. Most business owners have never worked this hard to keep their businesses open, and economic leaders have also never worked this hard to serve the community. It is a good reminder to ask business owners, council members, and other organizations like chambers and city officials to have some grace with each other.
- Staff has a letter drafted to send the City council and the Chamber to address the relationship with the FBID and then Chamber. Staff will send Director Davy the letter prior to the rest of the board for feedback & input. Director Kozlowski expressed support for current undertakings and enthusiasm to move forward and find solutions.
